- Revenue in Q2/2025 decreased by more than VND 6.8 billion compared to Q2/2024, equivalent to a 10.02% decrease due to construction projects under construction but revenue has not been recorded.

Due to the above-mentioned key reasons, after-tax profit in Q2/2025 decreased by VND 32,31 million VND compared to Q2/2024, equivalent to a 2.12% decrease.
