### **Article 2. Authorization to the Chairman of the Board of Directors:**

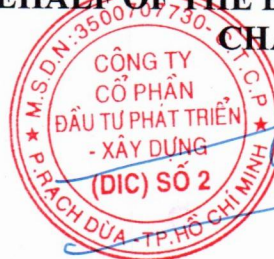
